

## Official Rules for the Racked LA-Wedding Salon Offer

### No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- Eligibility:** The **Racked LA-Wedding Salon** Offer (the “Offer”) is open only to legal US residents who are at least twenty-one (21) years of age who have internet access, and a valid email address. **Offer limited to the first 10 readers who enter the Offer as directed below.** Employees, independent contractors, interns, officers, directors, and agents of Sponsor, other companies associated with the Offer, as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses) and household members of any of the foregoing are not eligible to enter. **VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**
- Sponsor:** The Offer is sponsored by Vox Media, Inc., 1201 Connecticut Avenue, 11<sup>th</sup> Floor, NW, Washington, DC 20036 (“Sponsor”).
- Agreement to Official Rules:** By entering the Offer, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor’s decisions, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- Entry Period:** The Offer begins at 2:00:00 PM PT on January 11, 2016 and ends at 8:59:59 AM PT on January 13, 2016, or whenever 10 qualified readers have submitted the Entry, whichever occurs first (the “Entry Period”). Entries submitted before or after the Entry Period will not be eligible. Sponsor’s computer is the official time-keeping device for the Offer.

There is a limit of one (1) entry per person/email address during the Entry Period. Additional Entries will not be acknowledged. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any entries received through such methods, as determined by Sponsor, in its sole discretion. The first ten (10) qualified Entries to email Sponsor during the Entry Period will win. The odds of being selected depend on the number of entries received and the time in which they are received.
- Notification and Requirements of Potential Winners:** Winners will be contacted from Racked LA email account to the email address used to enter the Offer. Winners must allow for Sponsor contact him/her via message. Except where prohibited, a potential winner may be required to complete and return an affidavit of eligibility and liability/publicity release. If a potential winner fails to sign and return these documents within the required time period, an alternate potential winner may be selected in his/her place in a random drawing of all remaining entries received. In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the transmitting email account used to participate in the Offer. "Authorized account holder" is defined as the natural person who is assigned

to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

8. **General Conditions:** In the event that the operation, security, or administration of the Offer is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, Sponsor may, in its sole discretion, either: (a) suspend the Offer to address the impairment and then resume the Offer in a manner that best conforms to the spirit of these Official Rules; (b) award the prize(s) at random from among the eligible entries received up to the time of the impairment, (c) terminate the Offer without awarding any prize. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Offer or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Offer may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication by Sponsor. In the event of a dispute as to any online entry, the authorized account holder of the e-mail address used to enter will be deemed to be the participant. The “authorized account holder” is the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted e-mail address. The Offer is subject to federal, state, and local laws and regulations and is void where prohibited.

9. **Release and Limitations of Liability:** By participating in the Offer, you agree to release and hold harmless Sponsor, its parent, subsidiaries, affiliates, and each of their respective officers, directors, employees, and agents (the “Released Parties”) from and against any claim or cause of action arising out of participation in the Offer or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Offer; (b) technical errors related to computers, servers, providers, or telephone, or network lines; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Offer or the processing of entries; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Offer or receipt or use of any prize. You further agree that in any cause of action, the Released Parties’ liability will be limited to the cost of entering and participating in the Offer, and in no event shall the Released Parties be liable for attorney’s fees. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

11. **Disputes:** Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of, or connected with, the Offer or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Washington, DC. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of Sponsor in connection with the Offer, shall be governed by, and construed in accordance with, the laws of Washington, DC, without giving effect to any choice of law or conflict of law rules (whether of Washington, DC or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Washington, DC.
